Speakers

Guia Bianchi is a researcher at the Joint Research Centre in Seville of the European Commission. She is working to foster transformative innovation policies in EU territories with the initiative Partnerships for Regional Innovation (PRI). She is one of the co-author of GreenComp and a JRC report titled "Sustainability Competences", describing research done so far on sustainability competences, green skills and skills for the circular economy.

Felix Rohn's professional start made him explore the markets of Central and Eastern Europe as they emerged in the early 1990s.Today in charge of the Blueprint for sectoral cooperation on skills and working in the Pact for Skills team, he is the interface between his skills and qualifications unit in DG Employment and sectoral units in other DGs in the Commission.

Andreas Larsson is Regional manager of the managing authority of the ESF+ programme in the southernmost region of Sweden. Have worked with EU funding in different capacities since the late 1990's. The ESF is Europe's main instrument for supporting jobs, helping people get better jobs and ensuring fairer job opportunities for all EU citizens.

Dr. Lukas Kleine-Rueschkamp is the coordinator of local labour market analysis at the OECD. He leads and supervises the quantitative work on local economic development and changing local labour markets and skills demand. In his work, he focuses on the green and digital transitions, examining the geography of the risks and opportunities across different communities and sectors as well as analysing green skills gaps and transitions from polluting jobs and industries to green ones. Dr. Kleine-Rueschkamp holds a PhD in Economics from the University of Oxford
